

ACA Private Health Fund Information

The ACA have established agreements with nine Private Health Funds that will ensure ACA members are eligible to provide Counselling services through these schemes.

- Bupa
- Doctors Health Fund
- Medibank
- ahm
- Police Health Fund
- Saint Luke's
- Phoenix Health
- Emergency Services Health
- Grand United

Members do not have to apply for a Provider Number with the Doctors Health Fund or Grand United. Members of these health funds apply for their rebate directly with the health fund; however, you must give your client a copy of your current membership card so that the client can claim a rebate from the Doctors Health Fund.

Members do not have to apply for a Provider Number with St Luke's Health, Phoenix or Emergency Services Health if the member has a Police Health Fund Provider number already issued. The same health provider number is valid for the Police Health Fund, St Luke's Health, Phoenix and Emergency Services Health.










In addition to this you will need to provide copies of your current insurance policy along with a copy of your First Aid certificate (HLTAID003 or HLTAID011) and state each practice address on the application form (available from the ACA website).

Each private health fund has its own membership eligibility criteria. To help with this process please see the table on the following page.
